ORDER TO CEASE AND DESIST		

Defendant, the Board of County Commissioners of Delta County (hereinafter “County” or “Defendant”), by their undersigned attorney, pursuant to the Delta County District Court’s order dated September 5, 2013, states as follow.

1. The Delta County District Court issued its ruling in this case on September 5, 2013. The Court found that the adverse health impacts in the surrounding area were such that the development is incompatible with the neighborhood. The Court ordered Delta County to immediately issue a cease and desist order to Western Slope Layers and Rocky Mountain Layers.

2. Accordingly, this Order shall serve as notice to Western Slope Layers and Rocky Mountain Layers that they shall cease all egg laying operations immediately.
